

(Note: Long-time and short-time owners at Tiburon all understand that too often large bulk items are placed alongside the 2 dumpsters at Tiburon. This is both costly to the Association to have the city pick up the waste and unsightly for everyone. Below is an announcement of the annual Spring Cleaning, free, bulk pick up at Tiburon on March 23, 2024. Please review the announcement below and note the list of prohibited items (e.g., tires, building materials, hazardous waste, paint, oil, rocks, dirt) that the city will not pick up at any time of the year.)

Ocean City's Spring Clean Up service offers a convenient way for residents to get rid of large household items, such as furniture, appliances, bicycles, carpet, etc., which cannot normally be loaded into a standard refuse truck. Yard debris and shrubs are also permitted, however; the maximum diameter of tree limbs accepted is three inches. Further, this effort does NOT include the pick-up of full size trees or the pick-up of large demolition/remodeling projects.

The Spring Clean Up service is provided for residents only, as commercial properties are not included in the Spring Clean Up effort. For more information, call the Town of Ocean City's Solid Waste Division at 410-524-0318.

WINTER SCHEDULE

October 10, 2023 – May 12, 2024

RESIDENTIAL: (waste wheelers)
Monday – Oceanside (75th Street to 146th Street)
Bayside (75th Street to 135th Street)

Tuesday – All Areas (Inlet to 74th Street)
Bayside (136th Street to 146th Street)

COMMERCIAL: (Front-end and 300-gallon containers)
Monday/Wednesday/Friday – All Areas

SUMMER SCHEDULE

May 13, 2024 – October 7, 2024

RESIDENTIAL: (Waste wheelers)
Monday & Thursday – Oceanside (75th Street to 146th Street)
Bayside (75th Street to 135th Street)

Tuesday & Friday – All Areas (Inlet to 74th Street)
Bayside (136th Street to 146th Street)

COMMERCIAL: (Front-end and 300-gallon containers)
Monday/Wednesday/Friday/Saturday/Sunday – All Areas

REMINDER – In all locations, containers shall be placed at the curbside by no later than 6:00 am on the day of collection for emptying by the Solid Waste crews. These same containers must be placed back to the edge of the building by no later than 6:00 pm that same day.

A collection Fee is imposed for commercial establishments requiring collection more than five times per week. These establishments will include Hotels, Motels, Condominiums, Apartment/Multi-Family Complexes and Restaurants.

This fee structure will be in effect from mid-May to mid-October. The fee is \$100 per additional pickup per site visit regardless of container size.

In most cases the five-day collection schedule would exclude Tuesdays & Thursdays. Other days without collection may be possible if arranged in advance with the Solid Waste Manager. We are not in any way going to sacrifice the cleanliness of the Town. Therefore, the Solid Waste Manager shall have the final say on whether a particular location needs seven-day collection service.

NOTICE: All trash must be placed at the curbside by 6 AM on the specific dates of collection. Before any metal side load containers are repaired or replaced, please call 410-524-0318 as the Town of Ocean City is in the process of changing over to Front-End and 300-gallon plastic containers. All front-end containers and compactors with enclosures must have doors open for pick-ups. Doors must be opened by the employees of the business and closed after trash pick-up. All doors must have secure holding devices to keep doors open and closed. Compactor lights must be working at all times.

PROHIBITED CONTENTS

The following items should not be placed in a solid waste container:

- (1) Motor vehicle tires.**
- (2) Building materials (i.e wood, lumber, carpet/rugs).**
- (3) Hazardous, radioactive or medical wastes.**
- (4) Burning or smoldering materials or any other materials which would create a fire hazard.**
- (5) Rocks, dirt, sod, paint or motor oil.**

NOTICE: (Waste wheelers and 300-gallon containers)
Stolen or other abuse of the carts, which would render them unserviceable will be the responsibility of the owner and a replacement charge will be applicable. Residents leaving for the winter or leaving for more than a few days, are advised to put the waste wheeler inside or secure outside, to prevent the wind or someone from carting it off. **THE PROPERTY OWNER IS RESPONSIBLE FOR THE WASTE WHEELER.**

All metal dumpsters and plastic containers must be secured from being blown off pads into the streets. Name of the building or address must be on all dumpsters with letters no smaller than 3 inches. Owners must keep dumpsters painted, graffiti free, any wheels greased and clean on the inside.
